PLAYING RIGHTS BENEFITS

- Access to the Resort Pool and Gym.
 - Free mini golf for all playing rights holders and their direct family members.
 - Discounted Green fees at all listed reciprocal golf clubs.
 - 4 Free games of golf at Links Lady Bay. Subject to availability and playing rights. Must obtain a letter of introduction from New Terry prior to booking game.
 - Up to 3 guest players at a discounted rate at any one time. Subject to playing rights and availability.
 - 10% discount on eligible purchases from the Golf Shop, Bar and Café. Excludes promotional items unless otherwise determined by Management.
 - 10% discount off accommodation at BreakFree Wirrina Cove. Subject to availability, cannot be used for long weekends and public holidays.
 - 1 nights' accommodation (golf view room) free of charge when full payment of 12 months is made for 7 Day, 6 Day, 5 Day and Metro Playing Rights. Subject to availability (pro-rata Playing Rights payments excluded), cannot be used for long weekends and public holidays.
 - Vouchers included in Playing Rights payments are:
 - 7 day playing rights - \$100
 - 6 day playing rights - \$80
 - 5 Day playing rights - \$60
 - Metro playing rights - \$60
 - Under 21 playing rights - \$40
 - Under 18 playing rights - \$30
- Note:** Vouchers are provided in \$10 increments and may be redeemed in the Golf Shop, Bar and Café. No minimum spend is required. Any unused voucher amount is forfeited. Vouchers are only valid for the playing rights year and automatically expire at 31 July each year. Cannot combined with 10% discount.*
- All adult Playing Rights holders receive a discount on golf cart hire fees. ***Note:** under 18 years are not permitted to hire or drive a golf cart.*
 - Children under 15 years of the Playing Rights holder may play free of charge. Subject to playing rights and availability. (***Exclusions:** may not play prior to 11.00am on a Saturday, Sunday or Public Holiday*)

TERMS AND CONDITIONS

Playing Rights are available in the following categories:

- **7 Day** (Full Playing Rights 7 days per week, subject to availability)
 - **6 Day** (Full Playing Rights Sunday to Friday, subject to availability)
 - **5 Day** (Full Playing Rights Monday to Friday, including public holidays, subject to availability).
 - **Metro** (Full Playing Rights 7 days per week, subject to availability)
 - **Junior – under 21** (Full Playing Rights 7 days per week, subject to availability)
 - **Junior – under 18** (Full Playing Rights 7 days per week, subject to availability)
 - **Junior – under 15** (Full Playing Rights 7 days per week, subject availability), and must be accompanied by parent/guardian at all times.
1. Playing Rights are for 12 months (or pro-rata to 31st July) and are not transferable or refundable.
 2. Playing Rights fees are payable by 31st July 2026. In the event a new Playing Rights individual joins after 31st July, then pro-rata payments will apply (*will also apply to voucher amounts*).
 3. Wirrina Cove Golf Course and Mini Golf reserves the right to accept or reject any application at its absolute discretion.
 4. Wirrina Cove Golf Course and Mini Golf may suspend or terminate Playing Rights for any individual for breach of these terms and conditions at its absolute discretion. No refund shall be due following the suspension/termination of Playing Rights of the individual.
 5. Applicants must observe the Rules of Golf and always maintain acceptable social standards of behavior on the Course and at the Resort.
 6. Applicants must observe Dress Standards that are applied from time to time by the Resort and Wirrina Cove Golf Course and Mini Golf.
 7. Non-payment or late payment of Playing Rights fees shall result in immediate suspension of playing Rights. All monies owing must be paid in full, including any late payment fees, administration fees, joining fees and interest prior to restoration of Playing Rights.
 8. Wirrina Cove Golf Course and Mini Golf cannot and will not guarantee course availability to play at any time.
 9. Wirrina Cove Golf Course and Mini Golf cannot and will guarantee course availability and tee times for any Playing Rights holder. There will be times when the course is unplayable due to weather conditions, programmed and emergency course maintenance and where group bookings such as trade days have been provided exclusive use of the course.
